Technical information

The selection and installation of concrete street furniture and garden products requires specific knowledge, skills and tools. In order for the concrete products to maintain the performance declared by manufacturer and to be suitable to be used for their intended purpose for the entire warranty period, we recommend entrusting product selection and installation work to a certified company.

The occurrence of defects in the products as well as deterioration of the performance of the products may be caused by: 1) improper prediction of the loads actually acting on the pavement or failure to assess environmental factors, 2) improper installation of the pavement, 3) improper usage of the pavement.

The Minimum Requirements for the Installation and Use of Concrete Products are available on the manufacturer's website, www.betonomozaika.lt. These requirements are an integral part of this Declaration of Performance.

The existence/occurrence of white spots on the surface of the products is the consequence of the release of calcium carbonate (lime). The formation of such spots only confirms that Portland cement was used in the manufacture of the product, the natural hardening consequence of which is the release of lime.

The products can be transported by all modes of transport in accordance with the rules for the carriage of goods laid down for such transport. The products should be stored in packages or in stacks on a solid base, in accordance with occupational safety requirements. The products should be loaded, unloaded and stored in such a way that the products are not damaged.

The manufacturer provides a warranty in accordance with the procedure established by the Civil Code. The warranty conditions for the concrete products can be found on the manufacturer's website, www.betonomozaika.lt. If the warranty conditions are not complied with, the manufacturer cannot guarantee conformity of the products with the declared performance.
